## **Schematrentaquattro S.r.l. completes placement of 23,360,600 ordinary shares of Autogrill S.p.A. (“Autogrill”) and 23,300,480 ordinary shares of World Duty Free S.p.A. (“WDF”)**

Treviso, October 24, 2013

Schematrentaquattro S.r.l. (“Schematrentaquattro”), announces that it has completed the placement, previously announced on October 23, 2013, of 23,360,600 ordinary shares of Autogrill and 23,300,480 ordinary shares of WDF, corresponding, respectively, to 9.18% and 9.15% of Autogrill’s and WDF’s share capital, for a total amount equal to Euro 338 million.

The placement was carried out through an accelerated book built offering to institutional investors and closed at a price of Euro 6.50 per share of Autogrill and Euro 8.00 per share of WDF. The transaction will be settled by delivery of shares and payment of the consideration on October 29, 2013.

J.P. Morgan Securities plc acted as Sole Bookrunner for the placement.

As a result of the sale, Schematrentaquattro will hold approximately 50.1% of the share capital of both Autogrill and WDF.
